# Mental Health Specialist Apprentice

### **TYPICAL DUTIES:**

- Learns to provide direct patient care to clients in a 24-hour psychiatric facility or day treatment program; observes patients physical and psychological status; helps evaluate progress; records clinical notes on patient.
- Learns to assist professional staff in developing and modifying treatment plans; implements treatment plans.
- Learns to provide case management to mentally ill or elderly clients under the supervision of a team leader or experienced case manager; may provide counseling, money management or other related services.
- Assists in arranging for and providing transportation for clients.
- Learns to provide basic client counseling in groups as well as on an individual basis.
- Learns to perform administrative duties as required.



## Minimum Qualifications

<u>Knowledge of</u>: Basic knowledge or interest in concepts of mental illness, mental health and substance abuse; techniques of dealing with the physical, emotional and social needs of emotionally disturbed individuals or substance abusers; clinical terminology.
